



# **Our Belief**



(Child Protection, Education, WASH Youth Empowerment & Skill Development, and Disaster Risk Reduction & Emergency Response)

### a. Child Protection:

Nation Development Foundation works and collaborates with various Government and non Government stakeholders in creating a protective environment for children free from all forms of violence, abuse, exploitation, and neglect; strengthening community-based child protection mechanisms through effective implementation of child protection policies, legislation, services, and schemes; advocating and influencing legal and policy reforms in line with Global Conventions on the Rights of the Child ratified by Govt. of India in the state of J&K; and utilising a child rights programming framework keeping in mind the cross-cutting themes of child participation, non-discrimination and best interest of children while working with and for children for the realisation of their Rights.

We are strengthening health systems & nutrition services for all children and women. Effective implementation of health/medical schemes; preventing child marriage & reducing adolescent pregnancies; providing infrastructure and health services to improve the health status of communities.










### b. Education:

National Development Foundation, NDF collaborate with various Government and non-governmental stakeholders and works towards ensuring every child, especially the most marginalised those in greater danger of being left behind like girls and children with disabilities, enjoy their right to equitable and quality Education from early learning opportunities to secondary Education so that they reach their full potential; work for effective implementation of education policies, legislations, schemes and services; strengthening policy and legal reforms in line with the right to Education and providing infrastructure to improve education services.







# c. Water Sanitation and Hygiene (WASH):

National Development Foundation, NDF aims to improve general public health and transform the lives of communities by improving their access to safe Water, sanitation and hygiene; work and build partnerships with Government and non-governmental stakeholders to empower and enable communities to demonstrate sustainable WASH solutions to influence policy; improve access to water supply by leveraging government resources; construct toilets to stop open defecation for universal toilet use at households, school, institutions, and public places; improve hygiene practices by promoting knowledge and motivating change on main hygiene behaviours; strengthening linkages between government WASH facilities/schemes and communities, and promote safe waste management and disposal.







## d. Youth Empowerment and Skill Development:

National Development Foundation, NDF aims at creating a pool of young and independent people from a section of eligible and underprivileged youth and women through skill upgradation and livelihoods in accordance with market requirements to aid economic growth; skill up-gradation through vocational training of deserving and most marginalised youth and women; Gender equity and women empowerment; development and empowerment of youth and adolescents by utilising their limitless energies and potential through, Camping, Leadership programmes, Sports, cultural, literary and other youth activities which can inculcate among them a sense of patriotism, selfless service, the dignity of labour, fraternity, brotherhood and overall discipline in a broader sense.







### e. DRR and Emergency Response:

National Development Foundation, NDF aims to build resilience and reduce the vulnerability of communities, especially children, youth, and women, by improving community preparedness for emergencies.

In the aftermath of natural disasters; work and collaborate with Government and non-governmental stakeholders to reach out to the most marginalised& needy families affected by natural disasters to respond to their immediate essential needs and long-term rehabilitation; to promote and build leadership among children, youth, and women through community-based approaches enabling them to participate in the decision making process to respond effectively to humanitarian crises; and provide child-friendly spaces to cater to the children's psychological, nutritional, medical and protection needs.



# **Nature, Wildlife and Climate Change**

# a). Himalayan Wildlife and Environment Protection:

National Development Foundation, NDF aims to work with a wide range of stakeholders to conserve and protect Himalayan Wildlife and critical ecosystems for continued social, economic and environmental benefits. This programme of NDF focuses on environmental protection, conservation and awarenessbuilding partnerships with Government, research institutions, educational institutions and civil society organisations. NDF aims to effective implementation of environment & wildlife-related policies & legislation. To achieve the overall objectives of nature and wildlife conservation, we aim to work closely with communities, several leading scientists, conservationists, educators and experts from varied professional backgrounds with a passion for the conservation of nature and natural resources. As part of this programme, the focal area of our work will be Northern India in general and the Western Himalayas in particular. Ecotourism initiatives in natural areas and key wildlife habitats will be promoted as means for nature conservation and for providing alternate sources of livelihood.







# b). Climate Mitigation and Adaptation:

National Development Foundation, NDF aims to focus on various climate mitigation and adaptation strategies for reducing the impacts of climate change. This will be achieved by organising focused awareness programmes on different latest climate adaptation and mitigation strategies for Himalayan communities, through watershed development and tree planting drives and by promoting environmentally sustainable practices. Demonstration of environment-friendly pilot projects and policy and advocacy with the Government for strengthening environmental policy and frameworks will be key areas of our work. The main Focus of the climate adaptation and mitigation programme of NDF is creating awarenessamong a wide range of stakeholders about conserving nature and natural resources in their immediate vicinity. Healthy natural ecosystems will be promoted as a natural solution to deal with Climate Change at a regional level. Sustainable agricultural practices will also be promoted as a likely climate adaptation and mitigation strategy.

### c). Water and Wetlands:

National Development Foundation, NDF aims to document wetlands and wetland biodiversity of Jammu & Kashmir and Ladakh through on-the-ground research and citizen science initiatives. To achieve this, NDF will focus on developing strategies for conserving protected areas, especially National Parks, Wildlife Sanctuaries, and Wetland Conservation Reserves of Jammu & Kashmir and Ladakh. The programme will also focus on developing an alternate model for conservation within and outside protected areas. One of the key components of this programme will be biodiversity monitoring and conservation planning. This activity will generate knowledge through applied research and outreach activities. The programme aims to improve the management of biodiversity and ecosystems through various outputs to influence existing policies and conservation planning.

## **ANNUAL REPORT 2022-23**

### 2022-23 in Brief

The year 2022-23 was historical as NDF has completed thirty years of serving communities in need in Jammu & Kashmir (07.09.1992 - 07.09.2022).

During this year, the National Development Foundation J&K Jammu strengthenedearly childhood care and Education efforts as envisioned in National Educational Policy (NEP) 2020. This year, the NDF Team distributed 8000 pre-primary activity books to 8000 children, of which 3915 (48.93%) were girls and 4085 (51.06%) were boys. Apart from Education, the primary focus remained on child protection and the research project in the Kishtwar High Altitude National Park.

# a. Children & Youth Empowerment

# **Strengthening ECCE in Govt. Schools:**


After the National Education Policy(NEP) 2020 came into force, J&K's school Education departmentTook the bold decision of establishing Pre-primary wings (kindergartens),Thus Strengthening the Early Childhood Care and Education ecosystem as envisioned in the National Educational Policy (NEP) 2020. NDF also Joined hands with the School Education department and worked on the significant challenge of enrolment and retention in Govt—schools,especially in pre- Primary. The Major challenge was that no content was available for pre-primary classes; Samagra Shiksha developed the content in the shape of pre-primary workbooks for pre-primary 1,2 & 3 with the active participation of teams from SCERT, Directorates of School Education of both Jammu and Kashmir, National Development Foundation and Partners with the technical support from Unicef India. NDF also printed these books and became the IST organisation that provided books to more than 8000 children enrolled in pre-primary classes in government schools of the Jammu division directly through schools by the Education Facilitators engaged by the organisation. The details of the books disseminated by NDF are hereunder.

- Pre-School Activity Book-1 Vol-1 (3-4 yrs Children) ----- 4000 Books.
- Preschool Activity Book-2 Vol-1 (4-5 yrs Children) ----- 2000 Books.
- Preschool Activity Book-3 Vol-1 (5-6 yrs Children) ----- 2000 Books.

Before disseminating the books, the NDF organized the training of education facilitators of the Jammu Division on how to provide hand holding support to teachers and deliver Preschool Activity Books developed by the Department of School Education J&K to 8000 children in all ten districts of Jammu Division. Ms. Jaswinder Kaur, Coordinator of the Divisional Resource Centre for Pre-Primary Education in Jammu and Dr. Sarita Sharma, Assistant Coordinator of the Divisional Resource Centre for Pre-Primary Education in Jammu, acted as Resource Persons and imparted training to the Facilitators.

Mr. Rajiv Khajuria, President National Development Foundation, in his address, called upon the Education Facilitators that apart from delivering Preschool Activity Books they shall also facilitate the meeting of the School Management Committee and brief the concerned Corporator/Councilor or Sarpanch/Ward Member about the delivery of books in their area to ensure community participation and engagement with the school for strengthening ECCE component as enshrined in NEP 2020. This will also increase school enrollment, added Mr. Khajuria.

Apart from reaching out to 8000 children by providing them with Preschool Activity Books in the school setup, NDF also raised awareness among the School Management Committees of the five schools in each district of Jammu Division.


Our education facilitators distributed 8000 pre-primary activity books to 8000 children, of which 3915 (48.93%) were girls and 4085 (51.06%) were boys.


# **Distribution of Total Books Delivered- (Age wise)**

Distribution of Total Books (Age -Wise):









# **Facilitated the Educational Household Survey (Talaash)**

National Development Foundation J&K Jammu joined hands with Samagra Shiksha and UNICEF to facilitate the ongoing Talaash Survey for identifying, enrolling, and mainstreaming out-of-school children.

School Education Department's Samagra Shiksha Directorate requisitioned NDF to conduct Talaash survey in the Municipal Limits of the Jammu and Srinagar Municipal Corporations. To conduct this survey, NDF recruited 50 volunteers and deputed them with the nodal officers nominated by the education department both at Jammu and Srinagar.

NDF Education Team, and the Nodal Officers, Amit Jagotra (ZNO Jammu Zone), Mr. Vikas Khajuria and Mr. Mudassar from Samagra Shiksha, sensitized the volunteers on the Talaash app before sending them to the field. During the induction training, Sh. Ajit Sharma, coordinator Samagra Shiksha, ellaborated that Talaash survey is for identifying and mainstreaming OOSC between the ages of 6 to 18 years and informed that this has

To ensure the quality of the survey and handholding support to the School Education Department, NDF placed a team of experts to ensure a hassle-free Talaash survey in the best interest of the children in Jammu and Kashmir. NDF, asper the requisition given by the CEO of Jammu and Srinagar, engaged 50 volunteers from Jammu and 20 from Srinagar.



Before sending our field Volunteers to different areas to conduct the Mobile based education survey, i.e. Talaash survey, A one-day training / handholding support workshop was conducted during which the experts from the Samagra Shiksha Department acted as resource persons and provided training on Talaash App to 50 Volunteers of Jammu on 2nd of July 2022 at Tawi Conference Hall Udheywala Jammu and 20 volunteers at Srinagar.

NDF facilitated the School Education Department to reach 70000 households in Jammu and Srinagar. Project Director Samagra Shishka Sh. Deep Raj Kanethia JKAS, coordinator Quality Sh. Ajeet Kumar Sharma and Assit. Coordinator Quality Sh. Syed Fayaz Ahmed thanked the NDF for boosting the survey and providing technical support to DNOs.

# **Dissemination of Foundational Learning Study 2020**

To work on the action plan for making India Nipun Bharat by 2026-2027 and to discuss the required strategies, A workshop on 11th Nov was held at National Development Foundation, Tawi Conference Hall, Ram Janki Enclave.

During the workshop, Project Director Samagra Shiksha School Education Department, Er. Deep Raj Kanethia, while addressing, said that J&K UT will achieve Universal Foundational Literacy and numeracy at the end of Gradelll by 2026-27 through a National Mission, i.e. the National Initiative for Proficiency in Reading with Understanding and Numeracy (NIPUN Bharat).



He was speaking in a dissemination workshop of Foundational Learning Study 2020 organised by the Directorate of Samagra Shiksha J&K in collaboration with the National Development Foundation J&K Jammu and UNICEF.

The Officers from SCERT, CEO Offices and DIETs of all the districts of Jammu Division participated in the workshop. Ajeet Sharma, coordinator of Quality Samagra Shiksha and Syed Fayaz, Assistant Coordinator of Samagra Shiksha, acted as Resource Persons and disseminated the outcome of the foundational learning study 2022. In his address, Rajiv Khajuria, President/CEO of the National Development Foundation, highlighted the priority given to foundational numeracy and literacy in National Education Policy 2020. He emphasized that future schooling and lifelong learning for children is impossible without attaining foundational literacy & numeracy.

Project Director Er. While elaborating, Deep Raj Kanethia said that the research indicates that 80 to 90 % of the brain develops in children by the age of 6 to 7 years. He appealed that all education officers and functionaries should focus on building a solid foundation for better growth in the early years so that children attain foundational literacy and numeracy, which has been accorded the highest preference in National Education Policy 2020. He shared that LG J&K, Chief Secretary, and Principal Secretary of Education have given clear-cut instructions that the NIPUN Bharat Mission shall be a great success by ensuring that all children in Jammu & Kashmir attain proficiency in learning with understanding and numeracy. It is also a flagship programme of the Government of India and will help achieve SDG 4.1.1. The project director complimented the role of civil society, particularly the National Development Foundation and UNICEF, for joining the Education Department to ensure foundational numeracy and literacy are a reality for the children in Jammu & Kashmir. He detailed that National Education Policy 2020 also promotes voluntarism and the role of Civil Society Organisations to ensure inclusive and quality Education for all children.

# **DNOs review workshop on mainstreaming of OoSC held**

In collaboration with the Directorate of Samagra Shiksha, the School Education department and Unicef, NDF organised a workshop at Tawi Conference Hall Udheywala Jammu to review the progress on enrolment and mainstreaming of out-of-school Children in Jammu & Kashmir.Around 30 participants from all ten districts of the Jammu division comprising DNOs and Education Officers who are Nodal Points in their respective districts on enrolment and mainstreaming of Out-of-School Children participated. Vikas Khajuria, Assistant programmer, Dr Jagdish RajPanotra, and Dr Pourash Sharma Nodal officers from the Directorate of School Education Jammu also participated and interacted with the DNOs.



Ajeet Sharma, the coordinator of Quality Samagra Shiksha, advised DNOs to enrol children on Portal and not to see progress through the Portal. Syed Fayaz, the Assistant Coordinator of Quality Samagra Shiksha, discussed procedures regarding the age-appropriate admission process as per the RTE Act 2009. He informed that special training centres will be established on a need basis.

A group exercise was also organized in which participants deliberated on the challenges faced on the ground and the way forward. Samagra Shiksha also facilitated the DNOs by awarding them Certificates of Appreciation for their role in conducting the web-based Talaash Survey. A special certificate of appreciation was also awarded to National Development Foundation for their outstanding work and support during the Talaash Survey. Bilal Mir Dy. Director Planning Samagra Shiksha J&K distributed the certificates.

# **Traning of Education Functionaries on Mobile Based App (Talaash)**

After the surveyor and planner found technical glitches while surveying the Talaash mobile app. Two daysof training for resolving these glitches were held,i.e. on 11th June and 12th June, named as technical workshops for DNOs for both Jammu and Srinagar Division. Members of the Velocity Team conducted technical sessions. (Velocity Tech Solution, the technical developer of the Software)



50 Community Mobilisation meetings were conducted in 50 schools of 10 Districts of Jammu Division to sensitise the community about school readiness skills. The meetings were attended by parents, children, sarpanches, corporators, and SMCs. The total number of beneficiaries sensitised during the 50 community mobilisation meetings was more than 2000. In these meetings, the importance of the holistic development of a child was targeted, and SMCs motivated to create a child-friendly environment. Priority was also laid on the pre-primary education of children aged 3-6 years.

During these meetings, six hundred fifty-two parents, teachers, community members, students, SMCs, and other PRIs were sensitised.

These community meetings/campaigns were conducted by our consultants with the help of our core staff. They mostly focused on increasing enrolments in Govt. school.

During these campaign PRIs, some community members raised the issue of the less community linkage with the Government schools. The connection between government school teachers and community members needs a boost. Parental and community involvement in schools will help improve the quality in several ways advocated in these campaigns. Community members are responsible for supervising school administration, e.g. attendance and punctuality of teachers, attendance of students, abolition of corporal punishment and physical and mental harassment, regular health checkups for children and many more.

# **b. Nature Wildlife & Climate Change**

Research Project,i.e. Preparation of PRI-Based Geo-Referenced Biodiversity Assessment, Documentation and Conservation Plan of Wild Flora and Fauna of Kishtwar High Altitude National Park (KHANP)

National Development Foundation continued working on a prestigious project,i.e., preparing a PRI-based geo-referenced biodiversity assessment, documentation, and conservation plan of wild flora and fauna of Kishtwar High Altitude National Park (KHANP). The project is in partnership with following consortium partners:

- University of Kashmir
- Central University of Jammu
- Jawaharlal Nehru University (JNU)
- Local Settled / Nomadic Communities of Kishtwar

The project's primary objective is to document and assess the park's biodiversity, contributing to our understanding of the unique ecosystems thriving in high-altitude regions.

NDF has submitted reports to the Department of Wildlife Protection department, which are appreciated on record by the Hon'ble LG of J&K, among other senior officers.

The NDF research team is focusing on the fallowing aspects of the Kishtwar High Altitude National Park that are mentioned below.

**1. Bird Diversity Assessment:** The project focuses on identifying and documenting the avian species present within the national park. Bird surveys, including point counts, transects, and mist netting, are being conducted to record species diversity, population sizes and migratory patterns. The collected data will contribute to understanding the park's role in avian conservation and migration.

- **2. Mammal Species Inventory:** The research project aims to establish a comprehensive inventory of mammalian species inhabiting the Kishtwar High Altitude National Park. Field surveys, camera trapping, and DNA analysis techniques are being employed to identify and document mammal species, their population densities and habitat preferences.
- **3. Flora Composition and Distribution:** The study involves comprehensive vegetation surveys across different habitats within the park. Botanical techniques such as transect sampling, quadrat analysis and species identification are being utilized to determine the diversity, distribution and abundance of plant species. The collected data will aid in understanding the park's ecological processes, plant community dynamics and potential threats to vegetation.
- **4. Insect Biodiversity Assessment:** The project includes an assessment of insect biodiversity within the park. Various sampling techniques, such as sweep netting, pitfall traps and light trapping are being employed to capture and identify insect species. This research will contribute to knowledge of insect communities, their ecological roles and potential indicators of environmental change.


Conservation implications of Kishtwar Project: Presently the field research team based at the research station at Loharna in Dacchan area of Kishtwar is collecting all the research data. This collected data will undergo rigorous analysis to determine species richness, abundance, and diversity indices. Statistical models and Geographic Information System (GIS) will be utilized to understand the spatial distribution patterns of the studied taxa. The research findings will provide valuable insights into the ecological health of the Kishtwar High Altitude National Park and will aid in formulating conservation strategies to safeguard its biodiversity. The final DPR of the project will have all the information about various ecological aspects of the park and will have specific recommendations for conservation and management of the park.

**Education, Awareness and Capacity Building:** Simultaneously along with research in the park, in order to build capacity for the future the field researchers regularly visit the local educational institutions and conduct various education and awareness programmes related to the wildlife of Kishtwar High Altitude National Park. In order to build the capacity of the frontline staff of the National Park, the local staff actively participates in various research activities being conducted in the area. This will ensure the future sustainability of the ongoing research activities at Kishtwar High Altitude National Park.

The result of this report are encouraging and shall prepare the Department of Wildlife Protection for better conservation and management of Kishtwar High Altitude National Park which is important for the rare wildlife species and various ecological services it provides to the downstream communities.

In future, our conservation activities should be designed to protect our wildlife and generate employment opportunities for the local youth through various ecotourism activities.

I congratulate the Department of Wildlife Protection and National Development Foundation for bringing out this much-needed publication, and extend my best wishes to them for their future endeavours.
